BRUMBAUGH ELECTED AS CHAIRMAN OF HOUSE MAJORITY CAUCUS

OKLAHOMA CITY - State Representative David Brumbaugh (R-Broken Arrow) was elected Republican Caucus Chairman of the Oklahoma House of Representatives. The Republican Caucus consists of 72 members and is the majority party in the House. "It is an honor and a privilege to serve as chairman. We have a great opportunity to explore new ideas and build coalitions to better serve the people of Oklahoma," said Brumbaugh.

Rep. Brumbaugh was selected "Freshman Lawmaker of the Year" in 2011 and named Broken Arrow Elected Official of the year for 2013. He received recognition for 100% Conservative Index Ratings for the 2013 and 2014 sessions.

REP. BRUMBAUGH'S HB 1007 MARRIAGE AND RELIGIOUS FREEDOM BILL SIGNED INTO LAW

OKLAHOMA CITY - Governor Mary Fallin signed HB 1007 into law on May 1, 2015 by protecting pastors and religious officials who refuse to solemnize, recognize, or provide services for marriages that violate their religious beliefs. "It is considered landmark legislation in protecting religious freedom and liberty and the only such bill signed into law in 2015," Rep. Brumbaugh explained.



This is one of the most important bills of the legislative session. Brumbaugh has authored or co-authored over two dozen bills that have been signed into law.

Did you know? Rep. Brumbaugh had been awarded a 100% rating from the Oklahoma Farm Bureau for his 2014 voting record on key measures impacting agriculture and family farmers in our state.

OKLAHOMA CITY- A bill that increases transparency by providing greater notice and more public hearings in the eminent domain/urban renewal process was signed into law April 21, 2015. HB 1008 authored by State Representative David Brumbaugh (R-Broken Arrow) modifies the urban renewal process by protecting private property rights with better public openness.



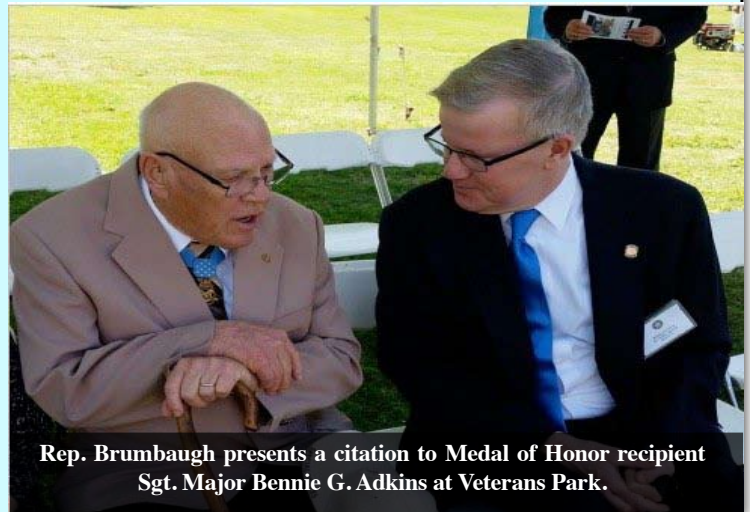

State Representative Recognizes Vietnam War Hero

BROKEN ARROW - Rep. David Brumbaugh recently awarded a special Certificate of Achievement on behalf of the Oklahoma Legislature to Congressional Medal of Honor recipient Command Sergeant Major Bennie G. Adkins.

"Sgt. Mjr Adkins heroic acts in 38 hour close combat at the Battle of A Shau in Vietnam represent that which is in the highest honor of our military and above and beyond the call of duty,"said Brumbaugh.

Rep. Brumbaugh, who is also a US Army veteran, called it one of the "greatest honors" of his life to spend time with Sgt. Major Adkins. "He is a wonderful man and an example of what true courage means."
